## **MINUTES OF MEETING**

On Tuesday, January 3, 2023, the DOTRA Directors held a Board meeting at Padrino's Restaurant. After establishing that there was a quorum present and following the Pledge of Allegiance, the meeting was called to order at 11:05 AM by President Clinton Griggs. The following were in attendance:

The minutes of the December 6, 2022 meeting were received and approved as distributed. The motion to approve the minutes was made by Mike Eckel and seconded by Sandy Furness.

<u>TREASURER'S REPORT</u>: The Treasurer's report was presented by Dave Bizuga. Balance as of 12/31/2022 was \$16,176.84, including \$5,140.60 in the checking account. A motion to accept this report was made by Bob Miller and seconded by Janis Stia. The report was filed for audit. With the resignation of Frank Stia, we need to fill the position of Assistant Treasurer.

<u>MEMBERSHIP REPORT</u>: Janis Stia reported that there is one new member to add. Kevin Conover, after 32 years in Multi-Modal Safety, requests annual membership (\$10.) in DOTRA. Janis moved that we accept Kevin's membership request; Andrea Mansfield seconded; the motion carried. \$10. was received for renewal of dues. The post office box rental is due soon. After a robust discussion, a proposal was made to cancel the PO box and have a Director receive the mail at their home. Ann Fratticcioli volunteered to do this. The Post Office will forward mail for one year after the PO box is closed. The change of address will be announced in DOTLine, on Facebook, on the membership application form and on every flyer. This move will save DOTRA \$182 a year. Janis is resigning as Membership Chair in April.
